## What is this product?

### Type

This product is an investment fund.

### PRIP term

There is no maturity date on this product.

### Objectives

**Investment objective** The objective of the Sub-fund MAPFRE AM - CAPITAL RESPONSABLE FUND is to provide balance between long term capital growth and protection of capital by the construction and management of a balanced portfolio of European equities and bonds. The investment process incorporates a framework to analyze the environmental and social impact of the entity related to the investment, as well as its governance. The goal is to favor companies and entities having a sound ESG (environment, social, governance) strategy as the managers believe that this gives a better risk return profile.

**Investment policy** The Sub-fund will invest in equity and fixed income assets of SRI (Socially Responsible Investment) compliant European public and private entities. Selection of assets will thrive to comply with commonly recognized SRI standards. The Sub-fund classifies as Article 8(1) under SFDR. Fixed income investments will include government or corporate debt securities both with an investment grade credit rating (a rating of not less than BBB- by any of the well-known rating agencies). Up to 10% of the Sub-fund's net assets may be invested in deposits.

The Sub-fund will invest a maximum of 50% of its assets in equities. Up to a maximum of 30% of the Sub-fund's net assets may be invested in debt instruments issued by EU Member States or Supranational Entities with at least an investment grade rating and complying with SRI criteria. This SRI methodology allows for a reduction of, at least, 20% of the ESG investment universe.

The Sub-fund may invest in below investment grade fixed income instruments if, at the time of investment, the credit rating of the issuer is investment grade (a rating of not less than BBB- by any of the well-known rating agencies). This type of investment shall at no point in time amount to more than 10% of the Sub-fund's assets.

The Sub-fund may invest up to 10% of its net asset in shares or units of UCITS and other UCIs and may not invest in UCITS or other UCIs that are managed by the Investment Manager or an affiliate thereof.

**Share Class Benchmark** the Stoxx 50 (net dividend reinvested), ICE BofAML Euro Broad Market Index and ICE BofAML Euro Treasury Bill Index

**Benchmark uses** The Sub-fund's benchmark is a basket of three indices: the Stoxx 50 (net dividend reinvested), ICE BofAML Euro Broad Market Index and ICE BofAML Euro Treasury Bill Index (the "Benchmark"). The Benchmark is solely used as a reference to compare the performance of the Sub-fund but not for the construction or choice of constituents in the portfolio. For this reason, the Sub-fund's portfolio might differ from the Benchmark.

**Derivative Policy** The Sub-fund may use financial derivative instruments traded on a regulated market for hedging or investment purposes. The Sub-fund may only use OTC derivatives for hedging purpose.

**Currency** The fund's base currency is EUR.

**Redemption and Dealing** The shares of the Sub-fund are redeemable on demand and dealt with on a daily basis.

**Distribution Policy** Income arising from the Sub-Fund will be accumulated. No dividend will normally be distributed.

### Intended retail investor

The Sub-fund may not be appropriate for investors who plan to withdraw their money within five (5) years.

## What are the risks and what could I get in return?

### Risks

## What happens if MAPFRE GROUP is unable to pay out?

If the Fund is not able to pay owed amounts to the investor, the investor is not covered by any national compensation scheme. Therefore, to protect the investor, the assets are held with a depositary company separate from the Fund which would liquidate the investments and distribute the proceeds to the investors in the event of default of the Fund. In such occurrence, it is possible to lose your entire investment.

### Recommended holding period: 5 years
